ELIGIBILITY FOR THE FELLOW AWARDS & BEST DOCTORAL THESIS AWARD (2026)

- **Fellow Awards (2026) (15 Awards). Eligibility:** Good publications in peer reviewer journals and academic merit.
- **Best Doctoral Thesis Award (2026) (7 Awards). (1 each in Botany/ Plant Science; Plant Biotechnology; Microbiology; Agriculture; Molecular Biology; Biochemistry; Environmental Sciences). Eligibility:** Best Doctoral Thesis Award nominations are open to candidates whose thesis has been awarded during 2024–25.

NOMINATION PROCEDURE:

- Eligible candidates for **Fellow Awards** must submit a **brief CV (1-2 pages)** along with their nomination, duly signed & stamped by the higher officials.
- Fellow** Nominations must be **endorsed and seconded** by at least two renowned scientists.
- Best Doctoral Thesis Award** nominations must be submitted through the Supervisor and should be accompanied with the brief summary of the thesis (1 page), its significance and application to the science and society. The nomination should be duly recommended and forwarded by the Head of the Department/Institution.
- Applications should be sent via email to The Chairman, Screening Committee (Awards-2026) at vegetosinfo@gmail.com
- In-service faculty/scientists** must submit their applications online, accompanied by a forwarding letter from their competent authority.
- All nominations will be screened and evaluated **by the Screening Committee (Awards & Honors)**. Tentatively finalized candidates (**FELLOW AWARD & BEST DOCTORAL THESIS AWARD**) will be requested to give an **online presentation** on the prescribed date which shall remain mandatory for final conferment of the award. The decision of the Chairman shall be final.
